Section 4 - First Aid Measures**Inhalation**

Emergency Procedures

Section 7 - Handling and Storage

Precautions for Safe Handling

Always read the label and any attached leaflet before use. Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

Engineering Controls

Section 10 - Stability and Reactivity

Reactivity

Reaction of the concentrate or spray mix with acids will precipitate solid dicamba and MCPA and largely de-activate the product and cause blockages in spray equipment.

Chemical Stability

Stable under normal conditions of storage and handling.

Possibility of hazardous reactions

The addition of a strong alkali such as caustic soda will cause release of dimethylamine vapour. Dimethylamine is moderately toxic.(LD50 (oral, rat): 700 mg/kg, TWA 2 ppm).

Conditions to Avoid

Heat, open flames and other sources of ignition.

Incompatible Materials

Strong oxidising agents, acids and alkalis.

The Australian Acceptable Daily Intake (ADI) for MCPA for a human is 0.01 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOEL of 1.1 mg/kg/day, the level determined to show no effects during long term exposure for the most sensitive indicators and the most sensitive species. ADI for Dicamba is 0.03 mg/kg/day, NOEL 3 mg/kg/day.

Do not use this container for any other purpose.

drumMUSTER is the national program for the collection and recycling of empty, cleaned, non returnable crop production and on-farm animal health chemical containers. If the label on your container carries the drumMuster symbol, triple rinse the container, ring your local Council, and offer the container for collection in the program.

Returnable containers: empty contents fully into application equipment. Replace cap, close all valves and return to the point of supply for refill or storage.
