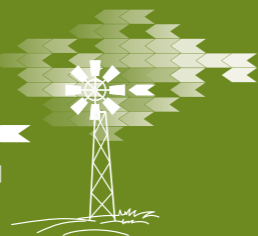

## Apparent Shout 720 Fungicide

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seeds and fertilisers. Triple-rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

### SAFETY DIRECTIONS

Attacks eyes and skin. Avoid contact with eyes and skin. DO NOT inhale spray mist. Repeated exposure may cause allergic disorders. Sensitive workers should use protective clothing. When preparing spray and using prepared spray wear cotton overalls buttoned to the neck and wrist, washable hat, elbow-length PVC gloves and goggles and disposable mist
